The District is seeking public input on its Draft 2024 Americans with Disabilities Act (ADA) Transition Plan (Draft Plan) for the following public and non-public facing District-owned facilities:

- 1) The San Rafael Transit Center (3rd Street and Hetherton Avenue, San Rafael)
- 2) Division 1 – San Rafael (1011 Andersen Drive, San Rafael)
- 3) Division 2 – Novato (1 Golden Gate Place, Novato)
- 4) Division 3 – Santa Rosa (1200 Piner Road, Santa Rosa)
- 5) Division 4 – San Francisco Bus Facility (121-125 Perry Street, San Francisco)
- 6) The Golden Gate Bridge Offices (Golden Gate Bridge Toll Plaza, San Francisco)
- 7) The Larkspur Ferry Terminal (101 East Sir Francis Drake Boulevard, Larkspur)

The Draft Plan provides a synopsis of the actions required to bring the facilities into compliance with the ADA, estimates the total cost to mitigate existing barriers, and includes projected completion dates for individual projects over the next four fiscal years.
