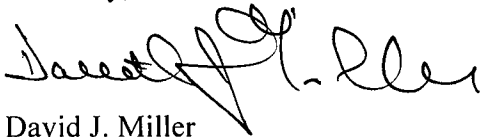
President Moylan and Members of the Board:
