

All items appearing on the agenda are subject to action by the Committee.

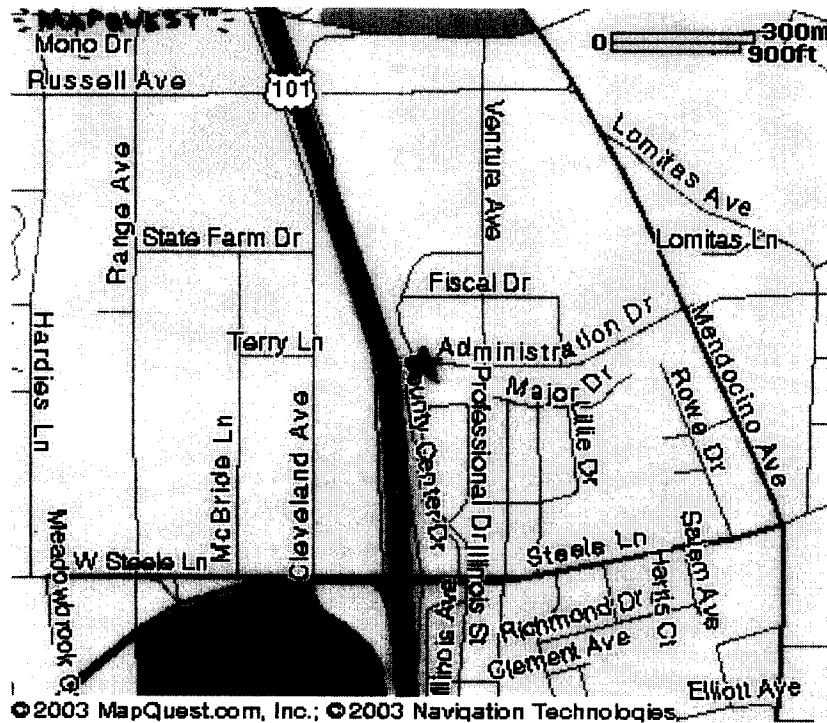
