**NOTICE IS HEREBY GIVEN** that sealed Statements of Qualifications (SOQs) from qualified firms for **Request for Statement of Qualifications (RFQ) No. 2011-FT-4, *Refurbishment of the M.S. ### **REQUEST FOR STATEMENTS OF QUALIFICATIONS (RFQ) NO. 2011-FT-4** **REFURBISHMENT OF THE M.S. SAN FRANCISCO FERRY**

The District seeks SOQs from qualified firms for the refurbishment of the M.S. San Francisco Ferry. The District will use the SOQs to determine which prospective Bidders will be eligible to bid on this project. It is mandatory that all prospective Bidders who have an interest in bidding on this project fully and properly complete the *Pre-qualification Questionnaire* requested herein. If all requested materials are not provided, the firm will be disqualified. SOQs shall be enclosed in a sealed envelope and marked "RFQ NO. 2011-FT-4, *REFURBISHMENT OF THE M.S. SAN FRANCISCO FERRY*" and plainly endorsed with the prospective Bidder's name and address.

Upon receipt of the *Pre-qualification Questionnaire*, the District will determine whether a prospective Bidder meets the minimum required qualifications. Only those prospective Bidders who meet the minimum qualifications, both for themselves and for their specified engineering resources, will be invited to bid on the project.

Questions concerning this RFQ shall be directed in writing only on **Tuesday, March 8, 2011, by 4:00 p.m. Pacific Standard Time**. The District will respond to questions no later than **Tuesday, March 15, 2011**.
