# DISTRICT'S DBE ADMINISTRATOR FEATURED IN THE FEBRUARY EDITION OF CALIFORNIA HIGH-SPEED RAIL'S SMALL BUSINESS NEWSLETTER

Artemise Davenport, the District's DBE Administrator, was featured in the February edition of California High-Speed Rail's Small Business Newsletter, Small Business Champion Spotlight. https://www.buildhsr.com/flipbook/vol 08 issue 01/#page=14. The article entitled, "From Toll Collector to Recruiting Small Businesses for Million Dollar Contracts" highlights her professional growth while at the District and her commitment to assisting disadvantaged businesses successfully navigate public agency contract opportunities. Artemise spearheaded the Business Outreach Committee, a highly successful group of Bay Area Transit Agency DBE professionals. Her partnership with Caltrans Calmentor program pairs small/disadvantaged businesses with larger architectural & engineering firms to allow these smaller business to gain traction in a highly competitive market. She is passionate about assisting small businesses do business with the District. She is proud to represent the District at the many outreach events that take place regularly throughout the year.

# THE DISTRICT IS TRACKING SEVERAL ASSEMBLY BILLS (AB) IN THE STATE LEGISLATURE

**AB-2057** San Francisco Bay area: public transportation, Introduced by Assembly Member Chiu. Existing law creates the Metropolitan Transportation Commission as a local area planning agency for the 9-county San Francisco Bay area with comprehensive regional transportation planning and other related responsibilities. Existing law also creates various transit districts located in the San Francisco Bay area, with specified powers and duties relative to the provision of public transit services. This bill would state the intent of the Legislature to later enact legislation relating to public transportation in the 9-county San Francisco Bay area. The specific details of the bill are still being developed, so the anticipated fiscal impact to the District is unknown at this time.

**AB-1350** Free youth transit passes: eligibility for state funding, Introduced by Assembly Member Gonzalez. Existing law declares that the fostering, continuance, and development of public transportation systems are a matter of state concern. Existing law authorizes the Department of Transportation to administer various programs and allocates moneys for various public transportation purposes. This bill would require transit agencies to offer free youth transit passes to persons 18 years of age and under in order to be eligible for state funding under the Mills-Deddeh Transit Development Act, the State Transit Assistance Program, or the Low Carbon Transit Operations Program. The bill also would require a free youth transit pass to count as a full

price fare for purposes of calculating the ratio of fare revenues to operating costs. Anticipated fiscal impact to the District is approximately \$1,000,000 in lost revenue.

AB-2012 Free senior transit passes: eligibility for state funding, Introduced by Assembly Member Chu. Existing law declares that the fostering, continuance, and development of public transportation systems are a matter of state concern. Existing law authorizes the Department of Transportation to administer various programs and allocates funds for various public transportation purposes. This bill would require transit agencies to offer free senior transit passes to persons over 65 years of age in order to be eligible for state funding under the Mills-Deddeh Transit Development Act, the State Transit Assistance Program, and the Low Carbon Transit Operations Program. The bill would require those free senior transit passes to count as full price fares for purposes of calculating the ratio of fare revenues to operating costs. Anticipated fiscal impact to the District is approximately \$2,000,000 in lost revenue.

**AB-2176** Free transit for UC, CSU and CCC students: This bill would require transit agencies to offer free student transit passes to persons attending the California Community Colleges, the California State University, or the University of California in order to be eligible for state funding under the Mills-Alquist-Deddeh Act, the State Transit Assistance Program, or the Low Carbon Transit Operations Program. The bill would also require a free student transit pass to count as a full price fare for purposes of calculating the ratio of fare revenues to operating costs.

# STATUS UPDATE RELATIVE TO THE REPAIRS RELATED TO THE SAN FRANCISCO FERRY TERMINAL FACILITIES AND THE M.S. SAN FRANCISCO FERRY

On November 23, 2018, the *M.S. San Francisco* Ferry ran into the District's Ferry Berths and the San Francisco Ferry Building Promenade. The vessel and facilities suffered significant damage, and immediate repairs of both the facilities and vessel were required in order to prevent the interruption or cessation of necessary District services. As reported to the Board at its December 21, 2018 and subsequent meetings, the District immediately commenced an investigation to determine the cause of the accident and an assessment of the extent of the damage to both the vessel and the District's and the Port of San Francisco's facilities.

In accordance with Public Contract Code Section 22050 and the District's Procurement Policy, the General Manager engaged the services of a number of firms. The vessel is back in service, and repairs to the District's facility will be underway shortly.

The repairs to the Port of San Francisco's promenade have not yet commenced and the costs have not been finalized. Moffatt & Nichol has performed the required inspections and is finalizing its repair recommendations. This portion of the work is also under review by our insurer.

Current costs to date for all activities related to the allision are \$2,425,913.65, a portion of which will be paid by the District's insurers. The General Manager will continue to provide the Board with regular updates on the status of this work, the costs, and the associated insurance reimbursements.

#### **BRIDGE TRAFFIC FOR THE MONTH OF JANUARY 2020**

Bridge southbound traffic for the month of January was 1,542,196 vehicles as compared to the previous year's total of 1,565,042 vehicles, which is less than a 1% change from the previous year. FasTrak<sup>®</sup> usage is 87% overall for January of 2019. This compares to 85% overall for the past rolling 12-months (February 2019 – January 2020) (Attachment).
