Recommendation

It is recommended that the Board of Directors approve the 2021 Board of Directors Meeting Schedule as presented in the Attachment.

Summary

For the past several years, the Board of Directors approved a calendar to meet once a month on the fourth Friday of the month except in May, November and December. The once a month meeting schedule was helpful and productive and staff is proposing the attached proposed calendar to continue a similar schedule for the 2021 year. Staff will continue monitoring agenda planning and meeting preparations to facilitate transition of each meeting during this time of remote meetings. If necessary, at the Board's discretion, a special Finance-Auditing meeting can be added to the calendar in May or June to discuss the adoption of the Draft Operating and Capital Budgets.

The Board and Standing Committee meeting schedule is subject to change throughout the year, and if a meeting is either cancelled or rescheduled, a public notice will be issued and appropriate notifications sent. If necessary, the Board may schedule special Committee or Board meetings.

After consultation with the President of the Board and District staff, the attached schedule shows the proposed monthly meeting schedule beginning in January 2021.

Fiscal Impact

There is a minimal financial impact associated with the proposed 2021 meeting schedule.
