Subject: **APPROVE ACTIONS RELATIVE TO ADOPTION OF THE CALPERS  
HEALTH CONTRACT RESOLUTIONS AND ASSOCIATED ACTIONS  
FOR UNION COALITION ACTIVE EMPLOYEES AND RETIREES**

### **Recommendation**

It is recommended that the Board of Directors approve adoption of the following CalPERS Health Program Resolutions for the Union Coalition employees and retirees (copies attached), each to be effective October 1, 2021:

1. Union Coalition Employees and Annuitants (CalPERS) Resolution;
2. Union Coalition Employees' Survivor Resolution (CalPERS) - for Survivors of Active Union Coalition Employees;
3. Union Coalition Annuitants' Survivor Resolution (CalPERS) - for Survivors of Deceased Retirees without Retirement Allowance,
4. Union Coalition Employees and Annuitants (Non-CalPERS) Resolution;
5. Union Coalition Employees' Survivor Resolution (Non-CalPERS) - for Survivors of Active Union Coalition Employees;
6. Union Coalition Annuitants' Survivor Resolution (Non-CalPERS) - for Survivors of Deceased Retirees without Retirement Allowance;
7. Union Coalition Employees' Less Than Half-Time Employees of (CalPERS); and,
8. Union Coalition Employees' Less Than Half-Time Employees of (Non-CalPERS)

### **Background**

At its meeting on June 26, 2020, the Board of Directors (Board) reviewed and approved a plan to transition health coverage for Golden Gate Bridge, Highway and Transportation District (District) employees and retirees to coverage under the CalPERS medical program for employees and retirees of public agencies that contract with CalPERS to provide such health benefits,<sup>1</sup> beginning with non-represented administrative employees ("non-represented") and those covered by the District's collective bargaining agreement with the Amalgamated Transit Union ("ATU").

<sup>1</sup>The CalPERS medical program is set forth in the Public Employees Medical and Hospital Care Act (PEMHCA).

On May 21, 2021, the Board of Directors ratified an agreement with Union Coalition bargaining units that provides for the transition of Union Coalition employees and retirees to coverage under the CalPERS medical program, effective October 1, 2021. As the next step in the CalPERS medical coverage transition process for the Union Coalition group, the Board of Directors must approve a series of Resolutions. These Resolutions adopt CalPERS contracting rules and options to implement the District's policies, and allow the District to implement the Union Coalition settlement agreement with regard to the structure of the CalPERS health care benefits for employees and retirees, such as the applicable employer contribution, and survivor coverage provisions. By adopting the above-stated Resolutions, the District elects to contract with CalPERS to provide medical benefits for these identified employees and retirees, effective October 1, 2021. These Resolutions are similar to the CalPERS Resolutions the Board of Directors adopted at its meeting on September 11, 2020 for non-represented and ATU employees and retirees. As with those Resolutions, there are separate Resolutions for Union Coalition employees and retirees who are covered by CalPERS for purposes of their retirement benefits, and those who are not.

#### CalPERS Resolutions for Employees and Annuitants

The CalPERS Resolutions for Employees and Annuitants (CalPERS' term for retirees) in both employee groups set forth the Minimum Employer Contribution (MEC) the District will make under the "unequal method" provided for in the CalPERS rules, as approved by the Board at the June 26, 2020 meeting.

#### CalPERS Resolutions for Active Employees' Survivor Coverage

The CalPERS Resolutions for survivors of active employees are required in order for the District to provide eligibility under its CalPERS medical plans for survivors of active employees, consistent with the District's current policies. Under this Resolution, a survivor of an active employee will be treated as eligible for CalPERS health coverage as an annuitant as of the date of the employee's death.

#### CalPERS Resolutions for Survivors Not Receiving a Retirement Allowance

Generally, survivors of retirees remain eligible for CalPERS medical coverage after the death of the retiree only if the survivor receives a retirement allowance from CalPERS or another pension plan covering District retirees. To provide for eligibility of surviving spouses of deceased retirees who may not receive a monthly retirement allowance but remain eligible for District-provided health coverage (applicable to survivors of those who retired prior to the effective date of October 1, 2021), the District also must submit Survivor Resolutions for Annuitants for both CalPERS and non-CalPERS surviving spouses. This allows the District to essentially "grandfather" survivors of existing retirees who are eligible to continue receiving District-provided medical benefits upon the retiree's death, regardless of whether the survivor receives a monthly retirement allowance.

#### CalPERS Resolutions for Employees Working Less Than Half-Time

CalPERS requires that special Resolutions be adopted to allow employees who work less than half-time, but are eligible for health coverage through collective bargaining (attached).

### Actuarial Analysis

The District has previously complied with the required provisions of Government Code Section 7507, which requires the disclosure of an actuarial study relative to the recommended transition, at a public meeting at least two weeks prior to enactment. This information was publicly provided at the June 25, 2021 District Board meeting<sup>2</sup>.

The actuarial study projected future costs of the transition for the Union Coalition. As the Board was informed at the June 25, 2021, meeting, this study projected that retiree health benefit plan changes to the July 1, 2019 Actuarial Obligations for the Union Coalition is a reduction in the unfunded actuarial accrued liability of \$637,000 and a reduction in the actuarial determined contribution (“ADC”) for FY 21/22 of approximately \$150,000.

### Fiscal Impact

There is no fiscal impact associated with this report.
