# REPORT OF THE GENERAL MANAGER BOARD OF DIRECTORS MEETING OF MARCH 25, 2022

The Honorable Board of Directors Golden Gate Bridge, Highway and Transportation District

Honorable Members:

#### AN ADDITIONAL \$75 MILLION

I am pleased to inform you that the U.S. Department of Transportation's Federal Transit Administration (FTA) announced on March 7<sup>th</sup> that it will award \$75 million to the Bridge District in American Rescue Plan (ARP) funding as part of a nationwide competitive program. The Bridge District is fortunate to be one of the 35 recipients in 18 states to receive funding through this discretionary program.

This one-time COVID relief money will be used to pay for the ongoing costs of providing bus and ferry service and backfill the missing Bridge tolls and transit fares associated with the continued diminished travel in the Golden Gate Corridor.

The size of the funding awards is based on the extent of the financial challenges facing an agency, so the \$75 million award to the District is a testament to the extent of our continued financial hurdles.

Fortunately, this money will keep our operations afloat for quite some time. Kudos to President Biden, Secretary Buttigieg, the Federal Transit Administration, Speaker Pelosi and the Bay Area Congressional delegation for recognizing our need for additional COVID relief funding.

## UPDATE ON IMPACTS OF THE COVID-19 PANDEMIC ON DISTRICT OPERATIONS

Fortunately, during the week of March 6<sup>th</sup>, we saw a slight uptick in transit ridership as more employers cautiously reopen their offices in downtown San Francisco. That having been said, travel remains well below pre-pandemic levels, whether by Bridge bus or ferry. Ridership was down on our buses by about 67 percent (we only carried 33 percent of our normal bus ridership) and our ferry ridership was down 71 percent (we are only carried 29 percent of our normal ferry ridership). Bridge traffic was down about 18 percent when compared to the same week, pre-COVID. The District is incrementally adding back bus and ferry service as we see the return of our customers travelling in the Golden Gate Corridor.

#### **REVENUES**

The District's revenues for the week of March  $6^{th}$  were down approximately \$1 million, highlighting the District's need for one-time federal COVID relief funding. Overall, Bridge traffic was down about 18 percent. Overall, bus ridership was down about 67 percent and ferry ridership was down 71 percent. The District collected about 82 percent of our pre-COVID amount of tolls, so tolls for transit were about 64 percent [(82-50) / 50 = 64%] of our usual amount, or tolls for transit were down about 36 percent last week.

#### **MASKING ON PUBLIC TRANSIT**

On March 10th, the Transportation Security Administration (TSA) extended the federal requirement mandating the wearing of masks on public transportation conveyances and in public transportation hubs through April 18, 2022. Accordingly, staff and customers onboard buses and ferries are still required to wear masks.

#### RESEARCH EFFORTS CONTINUE TO COLLECT WORKPLACE REOPENING DATA

The Metropolitan Transportation Commission (MTC) has partnered with the Bay Area Council to conduct monthly research with employers regarding their plans for reopening workplaces and bringing non-essential workers back. They have been surveying these employers for 11 months to monitor developments in workplace reopening plans. The survey results reflect information on Bay Area employers' return to work plans to assist transit agencies in planning for the future. #### UPDATE ON RISK TO BUS AND FERRY FUNDING

The Federal Transit Administration (FTA) is the principal source of funding for the District's bus and ferry capital projects as well as vital operating assistance during the pandemic. Before the District can receive money from FTA, the FTA sends a grant application to the United States Department of Labor (USDOL) for certification that the transit agency has not infringed upon the collective bargaining rights of its employees. This is known as a "13(c) certification".

On October 28, 2021, the USDOL, in response to objections raised by the Amalgamated Transit Union (ATU), released a letter formally nullifying their prior determination (issued in 2019) on the impact of the California Public Employees' Pension Reform Act of 2013 (PEPRA) on collective bargaining rights. Specifically, they now assert that PEPRA violates the collective bargaining rights of California transit workers.

The State of California has filed a motion for summary judgement seeking resolution of this matter. On January 27, 2022, the United States Department of Labor and the ATU submitted to the United States District Court for the Eastern District of California cross-motions and briefs in opposition to the State of California's motion for summary judgement. At the highest level, the cross-motions request that the Court deny the State's motion and instead rule in favor of USDOL and ATU, respectively. The State submitted a reply brief to the Court on February 4, 2022, and a hearing for summary judgement was held on February 17<sup>th</sup>. At this juncture, the Court has not yet ruled on the motion for summary judgement.




