REPORT OF THE GENERAL MANAGER BOARD OF DIRECTORS MEETING OF SEPTEMBER 23, 2022

The Honorable Board of Directors Golden Gate Bridge, Highway and Transportation District

DISTRICT BRIDGE PATROL PERSONNEL RECOGNIZED BY THE CALIFORNIA HIGHWAY PATROL

On Thursday, July 14, 2022, District Bridge Patrol personnel responded to a request for assistance from the California Highway Patrol (CHP). CHP Dispatch advised their units were out with a subject possibly armed with a gun at the Vista Point Parking Lot. In collaboration with the CHP Officers on scene, both Bridge Patrol and Roadway Services personnel worked together in a professional manner to ensure the safety of the public. Bridge Patrol Personnel provided ballistic shields to the CHP negotiating team while providing additional cover. Roadway Services personnel provided traffic control and assisted temporarily restricting access to the immediate area. This fluid situation was handled with tact, professionalism, a calm demeanor, and due regard for public and employee safety, reflected in the letters of commendation from the California Highway Patrol to the District personnel involved.

UPDATE ON SAN FRANCISCO FERRY TERMINAL RAMP REPAIR

On June 30, 2021 during a facility inspection at the San Francisco Ferry Terminal, a crack was discovered in one of the outer berth structural steel framing elements. Detailed inspections of both the inner and outer berth steel ramps were performed on July 6th and 7th, 2021 by District certified steel inspectors. The inspections revealed additional cracks in both the inner and outer berths after which both berths were red tagged and the terminal shut down.

In accordance with Public Contract Code Section 22050 and the District's Procurement Policy, the General Manager, on July 14, 2021, authorized an emergency procurement, Contract No. 2021-F-049, with Moffatt & Nichol to perform a thorough damage assessment and structural analysis of the inner and outer berths in order to determine the cause of the cracks and the structural condition of the berths. On August 17, 2021, Moffatt & Nichol submitted a draft damage assessment report that identified deficiencies in the existing hydraulic lift system and possible vessel surge as contributing factors in the damage. On November 19, 2021, Staff executed the first amendment to Contract No. 2021-F-049 with Moffatt & Nichol to provide engineering design services and to

prepare construction drawings and technical specifications associated with repairs to the inner berth. The District received the design documents on March 10, 2022 and applied for permit with the Port of San Francisco on March 11, 2022. The District received the Port of San Francisco permit for construction on April 18, 2022.

In accordance with Public Contract Code Section 22050 and the District's Procurement Policy, the General Manager, on April 22, 2022, authorized an emergency procurement, Contract No. 2021, Contract No. 2022-F-035, with Power Engineering Construction ("Power"), located in Alameda, CA, in the not to exceed amount of \$612,600 to perform repairs to the inner berth. On April 25, 2022, the District executed the second amendment to Contract No. 2021-F-049 with Moffatt & Nichol, in the amount of \$84,040 to provide construction engineering support services associated with construction Contract No. 2022-F-035.

Power is continuing preparing work plans and submittals for the work. Power has commenced with repairs to the inner berth concrete support beam and is fabricating temporary supports necessary to support the berth while repairing the structure steel cracks. Work is progressing.

The outer berth condition was determined to be worse than the inner berth and will require more extensive repairs. Engineering staff and Moffatt & Nichol have begun investigating outer berth repair options.

Fiscal Impact

Current estimated costs to date for all activities related to the structural steel cracks are \$3,532,723. The General Manager will continue to provide the Board with regular updates on the status and costs of this work.

UPDATE ON IMPACTS OF THE COVID-19 PANDEMIC ON DISTRICT OPERATIONS

Recreational and tourism travel has bounced back much faster than commute travel. Afternoon ferry trips from Sausalito to San Francisco, Giant's ballpark service and Angel Island service are quite popular. For example, from January through August of 2022 the Sausalito ferry has carried 5.5 times more bicycles than in all of 2021.

The return of commuters is much slower. Currently over 20 percent of all office space in downtown San Francisco is unleased. For the remaining 80 percent of office space where there is a tenant, employers and employees are sorting out what the new normal is for the work week. It will take some time for downtown San Francisco to recover and for new regional commute patterns to emerge. Fortunately, we have one-time federal COVID relief money to buy the District time to react to the new landscape.

During the week of September 4th ridership was down on our buses by about 62 percent (we only carried 38 percent of our normal bus ridership) and our ferry ridership was down 48 percent (we are only carried 52 percent of our normal ferry ridership). Bridge traffic was down about 15 percent when compared to the same week, pre-COVID

The District continues to add back bus and ferry service in a measured fashion consistent with the return of our customers travelling in the Golden Gate Corridor.

REVENUES

The District's revenues for the week of September 4th were down approximately \$940,000. As compared to the same week pre-pandemic, for the week of September 4th, Bus ridership was down 62 percent, ferry ridership was down about 48 percent and Bridge traffic down about 15 percent.

The District collected about 85 percent of our pre-COVID amount of tolls, so tolls for transit were about 70 percent [(85-50) / 50 = 70%] of our usual amount, or tolls for transit were down about 30 percent last week.

They have been conducting monthly surveys of employers to obtain information regarding Bay Area employers' return to work plans to assist transit agencies in planning for the future. After 16 months, they are now switching to conducting the survey every other month. As such, there was no survey in August. I will include information from their September survey in my October General Manager's Report.

After reviewing nominations submitted by District employees, the Employee of the Month Committee selected Senior Capital and Grant Programs Analyst, Jacob Brown, in the District Division, as the Employee of the Month for August 2022.

Mr. Brown is recognized for his role leading the District's Triennial Review process for the first time this year. He began by reaching out to participants early and keeping them informed throughout the entire process. He provided necessary documentation and offered and provided support to participants. Mr. Brown contributed his own labor to the process as well, providing documentation for areas covered by the Capital and Grants department. This was the District's third triennial review, and the process well-organized and transparent, with Mr. Brown at the helm. departments and staff from across the District participate in the Triennial Review, and Mr. Brown's efforts made the work more manageable. Mr. Brown exerted considerable effort in working with the City of Sausalito to write their first Title VI program ever and his experience and skill were of great benefit.

He is thoughtful about reaching out to people individually to solve problems and to ensure the work is completed in a timely manner.
