Subject: **REVIEW OF THE DISTRICT'S FY 22/23 FIRST QUARTER REPORT OF JUDGMENTS OR SETTLED CLAIMS**

As a reminder, all workers' compensation compromise and release (C&R) settlements resolve all future medical claims.
