UPDATE ON IMPACTS OF THE COVID-19 PANDEMIC ON DISTRICT OPERATIONS

Today 25 percent of all office space in downtown San Francisco is unleased. Stated another way, one out of every four floors of office buildings in downtown San Francisco is sitting vacant without a tenant occupying the space. Additionally, the office space that is leased is far from fully occupied. It will likely take some time for downtown San Francisco to recover along with Bridge, Bus and Ferry commute travel.

During the week of October 9th overall Bridge traffic was down about 16 percent when compared to the same week, pre-COVID. However, during the morning commute Bridge traffic was down about 30 percent.

The District operates two types of bus service: regional bus service that operates 23 hours per day up and down the Highway 101 Corridor between Santa Rosa to San Francisco (Routes 130, 150 and 101), and across the Richmond-San Rafael Bridge connecting the Del Norte BART station to the San Rafael Transit Center (Route 580); and commute bus service that provides express bus service with only a handful of bus stops before proceeding non-stop to the financial district in San Francisco. Examples of commute bus routes are the Route 114 (formerly Route 4) from Mill Valley and the Route 172 (formerly Route 72) from Santa Rosa.

During the week of October 9th overall ridership was down on our buses by about 58 percent (we only carried 42 percent of our normal bus ridership). Currently, ridership on our regional bus routes is about 80 percent of pre-pandemic levels, while ridership on our commute bus routes is about 20 percent of pre-pandemic levels. Of note, today about half of all riders on the District's buses are riding locally and are not crossing the Bridge.

During the week of October 9th our ferry ridership was down 52 percent (we are only carried 48 percent of our normal ferry ridership).

The District's revenues for the week of October 9th were down approximately \$960,000. As compared to the same week pre-pandemic, for the week of October 9th.

UPDATE ON IMPACTS OF THE COVID-19 PANDEMIC ON DISTRICT OPERATIONS (continued)

The District collected about 84 percent of our pre-COVID amount of tolls, so tolls for transit were about 68 percent [(84-50) / 50 = 68%] of our usual amount, or tolls for transit were down about 32 percent last week.

RESEARCH EFFORTS CONTINUE TO COLLECT WORKPLACE REOPENING DATA

The Metropolitan Transportation Commission (MTC) has partnered with the Bay Area Council to conduct research with employers regarding their plans for reopening workplaces and bringing nonessential workers back. They have been surveying these employers for 17 months to monitor developments in workplace reopening plans. The survey results reflect information on Bay Area employers' return to work plans to assist transit agencies in planning for the future. UPDATE ON ASSEMBLY BILL 2594 VEHICLE REGISTRATION AND TOLL CHARGES

On September 30, 2022, Assembly Bill 2594 was signed, a bill sponsored by Assemblymember Ting standardizing new toll penalty requirements and incorporating many practices already in place in at the Golden Gate Bridge and other Bay Area toll facilities. A few of the requirements of the bill will require changes to practices at the District including the provisions that extend the payment due date of invoices to 30 days (from the current 21), cap maximum penalties for a toll violation, provide a temporary low-income "COVID" waiver, and require a payment plan for low-income individuals. Staff will bring an item to the Board in the coming months that will amend the District's master ordinance to comply with the law and its implementation in the Bay Area by the District's regional partners. https://legiscan.com/CA/bill/AB2594/2021

UPDATE ON SAN FRANCISCO FERRY TERMINAL RAMP REPAIR

On June 30, 2021, during a facility inspection at the San Francisco Ferry Terminal, a crack was discovered in one of the outer berth structural steel framing elements. Detailed inspections of both the inner and outer berth steel ramps were performed on July 6th and 7th, 2021 by District certified steel inspectors. The inspections revealed additional cracks in both the inner and outer berths after which both berths were red tagged and the terminal shut down.

In accordance with Public Contract Code Section 22050 and the District's Procurement Policy, the General Manager, on July 14, 2021, authorized an emergency procurement, Contract No. 2021-F-049, with Moffatt & Nichol to perform a thorough damage assessment and structural analysis of the inner and outer berths in order to determine the cause of the cracks and the structural condition of the berths. On August 17, 2021, Moffatt & Nichol submitted a draft damage assessment report that identified deficiencies in the existing hydraulic lift system and possible vessel surge as contributing factors in the damage. On November 19, 2021, Staff executed the first amendment to Contract No. 2021-F-049 with Moffatt & Nichol to provide engineering design services and to prepare construction drawings and technical specifications associated with repairs to the inner berth. The District received the design documents on March 10, 2022 and applied for permit with the Port of San Francisco on March 11, 2022. The District received the Port of San Francisco permit for construction on April 18, 2022.

In accordance with Public Contract Code Section 22050 and the District's Procurement Policy, the General Manager, on April 22, 2022, authorized an emergency procurement, Contract No. 2021, Contract No. 2022-F-035, with Power Engineering Construction ("Power"), located in Alameda, CA, in the not to exceed amount of \$612,600 to perform repairs to the inner berth. On April 25, 2022, the District executed the second amendment to Contract No. 2021-F-049 with Moffatt & Nichol, in the amount of \$84,040 to provide construction engineering support services associated with construction Contract No. 2022-F-035.

Power completed the repairs to the inner berth concrete support beam. While performing the repairs, additional concrete spalls and deterioration in the concrete beam and the adjacent concrete deck slab were discovered. Power was directed to repair these areas also. Power is continuing fabricating the temporary supports necessary to support the berth while repairing the structure steel cracks. Work is progressing.

The outer berth condition was determined to be worse than the inner berth and will require more extensive repairs. Engineering staff and Moffatt & Nichol have begun investigating outer berth repair options.

Fiscal Impact

Power has incurred additional costs due to repairing the additional concrete deterioration. They have also incurred additional engineering costs for the lift system design and coordination with the Port of San Francisco. The additional costs are being finalized and are estimated at \$300,000. Current estimated costs to date for all activities related to the structural steel cracks are \$3,832,723. The General Manager will continue to provide the Board with regular updates on the status and costs of this work.

RECOGNITION OF KEY PERSONNEL INVOLVED CRITICAL INCIDENT RESUSCITATION EFFORTS

On Thursday, September 29, 2022, Bridge District Laborers notified the Sergeants Office of a bicyclist on the ground in the East Parking Lot. Bridge Patrol and Roadway Services Personnel arrived on scene. District personnel advised the person was not breathing and began Cardiopulmonary Resuscitation (CPR). A District Automated External Defibrillator (AED) delivered three separate shocks to the person. District Personnel, including California Highway Patrol (CHP), took turns administering CPR prior to the arrival of the San Francisco Fire Department (SFFD). Through shared efforts, it appeared the person regained a pulse and ability to breath prior to being transported by ambulance to California Pacific Medical Center in San Francisco.

In collaboration with the Bridge Laborers, Bridge Patrol, Roadway Services, Marin CHP, and SFFD, personnel worked together in a professional manner to save this person's life. Laborer Darrel Shinnett, Laborer Ignacio Mendez, Laborer Everardo Gudino, Chief Laborer Willis Whitfield, Patrol Officer Fabien Benjamin, Patrol Officer Kevin Horn, Sergeant Gabriel Jacquez, Patrol Officer Miguel Torres, Roadway Services Technician Miles Tupas are recognized for their professionalism, tact, teamwork, and a calm demeanor A special thanks to Sergeant Steve Fry for his dispatching roles in coordinating outside agency response.

RETIREMENT OF WILLIAM SANGREGORY, CHIEF OF ROADWAY SERVICES, BRIDGE DIVISION

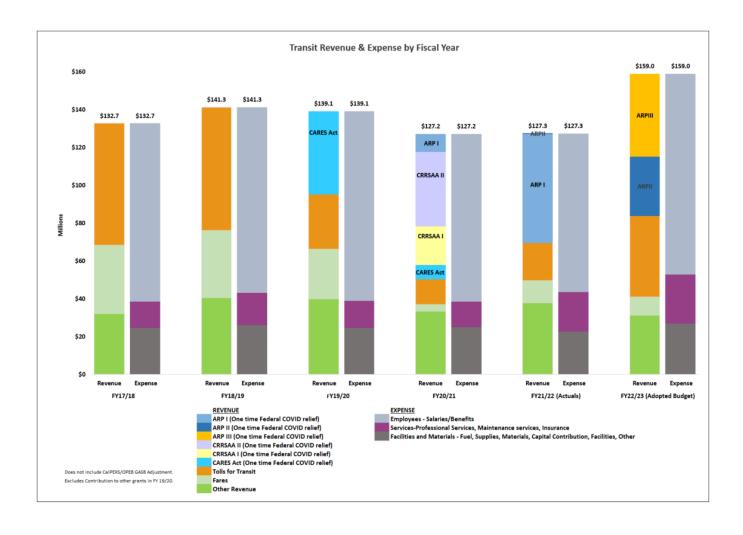
