ADOPT THE FINAL SHORT-RANGE TRANSIT PLAN (SRTP) FOR REGIONAL BUS, FERRY, AND PARATRANSIT SERVICE PREPARED FOR THE METROPOLITAN TRANSPORTATION COMMISSION FOR FISCAL YEARS 2022/2023 THROUGH 2027/2028

December 16, 2022

- **WHEREAS**, the Metropolitan Transportation Commission (MTC) requires Bay Area transit operators that receive federal funding through the Transportation Improvement Program (TIP) to prepare, adopt, and submit Short-Range Transit Plans (SRTPs) on an ongoing basis;
- **WHEREAS**, SRTPs are used by MTC to develop a long-range Regional Transportation Plan (RTP), which is implemented through the TIP by programming federal funds,
- WHEREAS, MTC typically requires the Golden Gate Bridge, Highway and Transportation District (District) to prepare an updated SRTP every two years; however, the current update was delayed due to the COVID-19 pandemic;
- **WHEREAS**, the SRTP does not require public hearings, but must be made available for public review and be formally adopted by the submitting agency;
- WHEREAS, a draft of the SRTP was made available for public review, and was submitted to MTC in September 2022 for review and comment;
- WHEREAS, MTC's comments and recommendations have been incorporated into the final SRTP;
- WHEREAS, as described in the staff report, the SRTP consists of a Transit System Overview, Transit Service Performance, Transit System Status, and Transit Service Plan;
- WHEREAS, the Transportation Committee, at its meeting of December 15, 2022, has reviewed and considered the SRTP and recommends its adoption by the Board of Directors for submission to MTC; now, therefore, be it
- **RESOLVED** that the Board of Directors of the Golden Gate Bridge, Highway and Transportation District hereby adopts the Final Short-Range Transit Plan (SRTP) for Fiscal Years 2022/2023 through Fiscal Years 2027/2028 for submission to the Metropolitan Transportation Commission.

CERTIFYING THE FINAL ENVIRONMENTAL IMPACT REPORT, ADOPTING FINDINGS OF FACT, AND A MITIGATION MONITORING AND REPORTING PROGRAM, AND APPROVING THE SAN RAFAEL TRANSIT CENTER REPLACEMENT PROJECT

December 16, 2022

THIS RESOLUTION IS ADOPTED WITH REFERENCE TO THE FOLLOWING FACTS AND CIRCUMSTANCES, WHICH ARE FOUND AND DETERMINED BY THE BOARD OF DIRECTORS:

WHEREAS, the Golden Gate Bridge, Highway and Transportation District (District), in its role as lead agency, has prepared an Environmental Impact Report (EIR) pursuant to the requirements of the California Environmental Quality Act (CEQA) (Public Resources Code Section 21000 et seq.) for the San Rafael Transit Center Replacement Project (the Project);

WHEREAS, on March 20, 2018 and June 12, 2018, the District held two public meetings to present information regarding the Project and to solicit preliminary feedback from members of the public;

WHEREAS, on October 16, 2018, the District issued a Notice of Preparation (NOP) of an EIR for the Project to advise interested parties that an environmental study was being prepared to consider the potential impacts of the Project;

WHEREAS, a public scoping meeting was held on October 30, 2018 to receive comments regarding the scope of issues to be addressed in the EIR;

WHEREAS, in compliance with applicable CEQA requirements, a Draft Environmental Impact Report (DEIR) was prepared and issued for agency and public review and comment on August 11, 2021, for a review period which ended on October 12, 2021;

WHEREAS, on October 5, 2021, the District extended the public review period for an additional 3 weeks to November 2, 2021;

WHEREAS, the District received over 100 comments on the DEIR and the Project during the DEIR comment period;

WHEREAS, a Final Environmental Impact Report (Final EIR), incorporating responses to comments on the DEIR, was issued on October 27, 2022;

WHEREAS, additional responses to comments on the DEIR were issued on November 8, 2022 and December 5, 2022;

WHEREAS, the Final EIR consists of the text of the DEIR, as amended, comments received on the document and responses to comments on the DEIR, items included in attachments

to this Resolution, and all documents and resources referenced and incorporated by reference in the Final EIR;

- **WHEREAS,** the Final EIR has been completed in compliance with CEQA, the Guidelines for Implementation of the California Environmental Quality Act (14 Cal. Code of Regs. Section 15000 *et seq.*) (the State CEQA Guidelines) and local procedures adopted pursuant thereto;
- WHEREAS, on December 15, 2022, the District's Transportation Committee recommended that the Board of Directors Certify the Final EIR and adopt findings, a mitigation monitoring and reporting program, and approve the Move Whistlestop Alternative (the preferred Project alternative);
- **WHEREAS**, the Board of Directors (Board) considered the Final EIR at a meeting held on December 16, 2022;
- **WHEREAS**, the Final EIR identified certain significant and potentially significant adverse effects on the environment that would be caused by the implementation of the Project as proposed;
- WHEREAS, the Final EIR outlined various mitigation measures that would substantially lessen or avoid certain of the Project's significant effects on the environment, as well as alternatives to the Project, one of which would provide some environmental advantages;
- WHEREAS, the District is required, pursuant to CEQA, to adopt all feasible mitigation measures or feasible project alternatives that can substantially lessen or avoid any significant environmental effects of a proposed project;
- WHEREAS, Public Resources Code Section 21081, subdivision (a), requires a public agency, before approving a project for which an EIR has been prepared and certified, to adopt findings specifying whether mitigation measures and, in some instances, alternatives discussed in the EIR, have been adopted or rejected as infeasible;
- WHEREAS, Exhibit A to this Resolution includes a set of Findings of Fact prepared in order to satisfy the requirements of Public Resources Code Section 21081, subdivision (a);
- WHEREAS, as the Findings of Fact explain, the Board, reflecting the advice of District Staff and extensive public input, acting at its meeting of December 16, 2022, approved the Move Whistlestop Alternative (the preferred Project alternative);
- WHEREAS, in taking this course, the Board has acted in conformance with CEQA in considering project mitigations and/or alternatives as a means of substantially lessening or avoiding the environmental effects of the Project;
- WHEREAS, all significant and potentially significant environmental effects associated with the Move Whistlestop Alternative of the Project, as approved, can either be substantially lessened or avoided through the inclusion of mitigation measures proposed in the Final EIR;

WHEREAS, the Board in approving the Project as proposed intends to adopt all mitigation measures set forth in the Findings of Fact and the Mitigation Monitoring and Reporting Program;

WHEREAS, the Board has determined, for reasons set forth in the Findings of Fact, that environmental impacts of the Adapt Whistlestop Alternative would be similar to or slightly less than the impacts identified for the preferred alternative, the Move Whistlestop Alternative, and for those reasons the Adapt Whistlestop Alternative is considered the environmentally superior alternative (though neither the Adapt Whistlestop nor the Move Whistlestop alternatives would result in significant and unavoidable environmental impacts);

WHEREAS, the 4th Street Gateway Alternative and the Under the Freeway Alternative would both result in significant environmental effects that cannot be avoided or substantially lessened by the adoption of feasible mitigation measures, and impacts resulting from those alternatives would therefore be significant and unavoidable;

WHEREAS, the Board recognizes the District's obligation, pursuant to Public Resources Code section 21081.6, subdivision (a), to ensure the monitoring of all adopted mitigation measures necessary to substantially lessen or avoid the significant effects of the project; and

WHEREAS, Exhibit B to this Resolution is the Mitigation Monitoring and Reporting Plan prepared in order to comply with Public Resources Code section 21081.6, subdivision (a); now, therefore, be it

RESOLVED by the Board of Directors (Board) of the Golden Gate Bridge, Highway and Transportation District (District) as follows:

- 1. The foregoing recitals are true and correct and incorporated herein by reference;
- 2. In approving this Resolution, the Board certifies that the Final EIR has been completed in compliance with the California Environmental Quality Act and the State CEQA Guidelines;
- 3. In approving this Resolution, the Board hereby finds that it has independently reviewed and analyzed the Final EIR and considered the information contained therein and all comments, written and oral, received prior to approving the Resolution;
- 4. In approving this Resolution, the Board hereby finds that the Final EIR reflects the District's independent judgment and analysis, as required by Public Resources Code Section 21082.1;
- 5. In approving this Resolution, the Board adopts Exhibit A (attached hereto) in order to satisfy its obligations under Public Resources Code Sections 21002 and 21081, subdivision (a) regarding the changes or alterations made to the Project to mitigate or avoid environmental impacts;
- 6. In approving this Resolution, Board adopts Exhibit B attached hereto in order to satisfy its obligations under Public Resources Code Section 21081.6, subdivision (a) to ensure the

Based on and in consideration of all of the foregoing, the Board hereby adopts the Move Whistlestop Alternative as described in the Final EIR, along with, and conditioned by, the mitigation measures, which are described in the Findings of Fact attached as Exhibit A and reflected in the Mitigation Monitoring Plan attached hereto as Exhibit B, which shall be incorporated into and be a part of the approved alternative;
- 8. Consistent with Public Resources Code Section 21081.6, the documents that constitute the record of proceedings for approving the Project are located at the District's offices at 1011 Andersen Drive, San Rafael, CA 94901-5318, and the custodian of these records is Raymond Santiago, Manager of Traffic Engineering and Transit Facilities; and
- 9. The Board hereby directs District staff to file with the County Clerk of Marin County and the Office of Planning and Research a Notice of Determination commencing the 30-day statute of limitations for any legal challenge to the project based on alleged non-compliance with CEQA.

APPROVE THE IMPLEMENTATION OF THE 2023 LEGISLATIVE PLATFORM

December 16, 2022

WHEREAS, the Golden Gate Bridge, Highway and Transportation District (District) is preparing for the 2023 State and Federal Legislative sessions, working actively with its legislative advocates to follow a variety of non-pandemic and post-pandemic-related issues that affect or potentially could affect the operations of the District;

WHEREAS, since the effects of the pandemic in March 2020, the District has been fiscally prudent in managing its one-time federal COVID-19 relief funding to address the financial shortfall associated with the drop in travel in the Golden Gate Corridor;

WHEREAS, Staff from various Bay Area transit agencies are now working together to secure multi-year funding to avoid the "fiscal cliff" while at the same time devoting our existing resources to reinvigorating public transportation ridership;

WHEREAS, funding for the final phase of the Seismic Retrofit Project of the Golden Gate Bridge is also still at the forefront of our legislative priorities and staff is optimistic the project will achieve its funding goal;

WHEREAS, in 2023, the District will continue to focus on seismic funding but also will monitor legislative bills that could have a funding impact on the District's overall operations and specific to the California State legislative session, District staff will continue to monitor and weigh-in on potential legislation affecting the District and our partner transit agencies while keeping in mind the District's resolution declaring a climate emergency and the District's resolution regarding racial equity and justice;

WHEREAS, approval of a legislative platform establishes Board-approved priorities to provide direction on legislative and policy activities on important issues;

WHEREAS, the Governmental Affairs and Public Information Committee at its meeting of December 16, 2022, has so recommended; now, therefore, be it

RESOLUTION NO. 2022-104

FINDING THAT THE PROCLAIMED STATE OF EMERGENCY CONTINUES TO IMPACT THE ABILITY TO MEET SAFELY IN PERSON

December 16, 2022

WHEREAS, on March 4, 2020, Governor Newsom declared a State of Emergency to make additional resources available, formalize emergency actions already underway across multiple state agencies and departments, and help the State prepare for a broader spread of COVID-19;

WHEREAS, on March 17, 2020, in response to the COVID-19 pandemic, Governor Newsom issued Executive Order N-29-20, which suspended certain provisions of the Ralph M. Brown Act in order to allow legislative bodies to conduct meetings electronically without a physical meeting place;

WHEREAS, on June 11, 2021, Governor Newsom issued Executive Order N-08-21, which specified that Executive Order N-29-20 would expire on September 30, 2021;

WHEREAS, on September 16, 2021, the Governor signed Assembly Bill 361 into law as urgency legislation that goes into effect on October 1, 2021, amending Government Code Section 54953 of the Brown Act to allow legislative bodies to continue to meet remotely during a proclaimed state of emergency, provided certain conditions are met and certain findings are made;

WHEREAS, the Governor's proclaimed State of Emergency remains in effect, and State and local officials, including the California Department of Public Health and the Department of Industrial Relations, have imposed or recommended measures to promote social distancing.

NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS:

- 1. The Board of Directors of the Golden Gate Bridge, Highway and Transportation District has reconsidered the circumstances of the State of Emergency, and finds that:
 - a. The factors triggering the State of Emergency continue to directly impact the ability of the members of the Board and members of the public to meet safely in person; and
 - b. State or local officials continue to recommend measures to promote social distancing.
- 2. The District will comply with the requirements of Government Code Section 54953(e)(2), when holding Board and committee meetings pursuant to this Resolution.
- 3. The Board of Directors will reconsider the circumstances of the State of Emergency and revisit the need to conduct meetings remotely within 30 days of the adoption of this Resolution.
