# (3) Report on a Memorandum of Understanding with the Marin Community College District for the Golden Gate Bus Coach Operator Apprenticeship Program [09:02 Minutes Mark on the Audio Recording]

Deputy General Manager/Bus Transit Division Mona Babauta presented the staff report and presentation.

She expressed appreciation to the program partners and others at the District including:

- Board members for their commitment to racial equity and ending systemic racism;
- Bus Operator mentors;
- Amalgamated Transit Union (ATU) Local 1575;
- Canal Alliance;
- California Transit Works;
- College of Marin;
- Santa Rosa Junior College;
- Human Resources Department; and
- District's legal team at Hanson Bridgett LLP.

She spoke about the effectiveness of the District's labor-management partnership with ATU Local 1575.

Mr. Mulligan expressed appreciation to Ms. Babauta, her team and all the involved partners. He said that the District has received \$1 million in grants for the program. He highlighted that Canal Alliance has also received a \$500,000 grant to support this program along with other programs.

Chair Hernández and Director Thier expressed appreciation for Ms. Babauta's report, the program, and the team's efforts.

Director Garbarino expressed appreciation for the program and the contributions of Canal Alliance. She commented about management opportunities for Bus Operators.

President Thériault expressed appreciation for updated Bus Operator requirements, which allow applicants to substitute the apprenticeship program for a high school diploma. He commented about the challenges of meeting the high school requirement.

Director Thier expressed appreciation for the professional development opportunities, and said that the program really supports the District's equity goals. She highlighted that she admires how the team has identified barriers to becoming Bus Operators and incorporated elements into the program to address those obstacles. She spoke about the many benefits of the program.

Director Hill inquired about opportunities for the apprentices to participate in the Bus Roadeo and he encouraged the Board members to attend the event.

Chair Hernández expressed appreciation for the partnerships and spoke about the importance of the approach. She said she had met the first apprentice class at a Bus Operator appreciation event and observed the apprentices' eyes reflected hope and optimism for their future. # (3) State Update from the District's Legislative Advocates, Platinum Advisors, LLC [00:25 Minutes Mark on the Audio Recording]

Steve Wallauch of Platinum Advisors, LLC presented the State Update. He reviewed legislative activity related to the budget and tax revenue. He overviewed the California Transit Association (CTA) proposal for funding transit operations. He said that legislators may require transit operators to meet performance measures and submit reports in exchange for funding.

He reviewed the Brown Act related bills including Assembly Bill (AB) 557, AB 817, AB 1379, Senate Bill (SB) 411 and SB 537, and a few other bills.

Chair Cochran inquired about the effect of the delay in the tax returns and the scope of SB 411.

Mr. Wallauch responded to the Director's inquiries. He said that, as a result of the delayed tax returns and revenue, the state budget deficit could be as high as \$30 billion. He confirmed SB 411 applies to Los Angeles.

General Manager Denis Mulligan presented the staff report. He highlighted some key legislation proposing to amend the Brown Act, including AB 817 and SB 537.

<u>Directors GROSBOLL/HERNANDEZ</u> moved and seconded to amend their motion to recommend that the Board support SB 537 and AB 817.

Director Hill commented about increased attendance at the District's Advisory Committee meetings while such meetings were held by telephone and other electronic means (remotely).

Director Garbarino inquired about SB 537.

President Theriault inquired about the possibility that SB 537 and AB 817 could be amended.

<u>Directors GROSBOLL/HERNANDEZ</u> moved and seconded to further amend their motion to recommend that the Board approve support for SB 537 and AB 817 as currently drafted and amended, and other bills relative to the Brown Act with similar goals: a) advisory committees could meet remotely and b) regional legislative body members could attend remotely if they have to travel a long way to reach the meeting in person.

Director Grosboll inquired about the SB 537 bill and the 40-mile rule.

Director Rabbitt said that his home is 41 miles away from the Board's current meeting location. He commented about the value of attending meetings in person and expressed support for AB 817.

Chair Cochran inquired about the possibility that SB 537 and AB 817 could change.

### [Director Safaí arrived.]

Mr. Wallauch and Mr. Mulligan responded to the Directors' comments and inquiries. Mr. Wallauch said that the bills specify members that attend remotely must be seen (on video) as well as heard. Mr. Mulligan said that the Board could approve advocacy of bills with the same general goals of AB 817 and SB 537: a) advisory committees could meet remotely and b) regional legislative body members could attend remotely if they have to travel a long way to reach the in-person meeting. Mr. Wallauch clarified that, as amended, SB 537 states that if a meeting location is more than 40 miles away from a legislative body member's office, he or she can participate remotely. He acknowledged that the bills could change further.
