December 15, 2023

WHEREAS, the approaches of the Golden Gate Bridge and the surrounding areas are located on federal land administered by the Department of Interior, National Park Service (NPS), and the Golden Gate National Recreation Area (GGNRA);

WHEREAS, the NPS, as the agency administering the lands around the Golden Gate Bridge, required the District to obtain a Special Use Permit (SUP) for the right of entry for access, mobilization, staging, construction and site restoration associated with the Golden Gate Bridge Physical Suicide Deterrent System and Wind Retrofit construction;

WHEREAS, on October 8, 2015, by Resolution No. 2015-089, the Golden Gate Bridge, Highway and Transportation District's (District) Board of Directors (Board) approved entering into a SUP with the NPS for a term of four years, which expired on December 31, 2019;

WHEREAS, on December 20, 2019, by Resolution No. 2019-086, the Board authorized execution of Amendment No. 1 to the SUP extending the SUP term to December 31, 2023, and updating and adding conditions to the SUP;

WHEREAS, the construction under Contract No. 2016-B-1, Golden Gate Bridge Physical Suicide Deterrent System and Wind Retrofit, will not be completed by December 31, 2023;

WHEREAS, District and NPS staffs have tentatively agreed to amended terms and conditions to the SUP to extend its term and to make other necessary changes, as outlined in the staff report;

WHEREAS, a capital budget increase of \$194,868, to be funded with cell site revenues, is required to fully fund the NPS SUP for the proposed additional four years of its term; and,

WHEREAS, the Building and Operating Committee has so recommended, and the Finance-Auditing Committee has concurred, at their meetings of December 14, 2023, now, therefore, be it

**RESOLVED** that the Board of Directors (Board) of the Golden Gate Bridge, Highway and Transportation District (District) hereby approves actions relative to the National Park Service Special Use Permit (SUP) for Contract No. 2016-B-1, *Golden Gate Bridge Physical Suicide Deterrent System and Wind Retrofit*, as follows:

## APPROVE ACTIONS RELATIVE TO THE GOLDEN GATE BRIDGE PHYSICAL SUICIDE DETERRENT SYSTEM PROJECT

December 15, 2023

WHEREAS, by Resolution No. 2016-087, the Golden Gate Bridge, Highway and Transportation District (District) Board of Directors (Board) authorized the award of construction Contract No. 2016-B-01, *Golden Gate Bridge Physical Suicide Deterrent System and Wind Retrofit Projects*, to Shimmick Construction Company, Inc./Danny's Construction Company LLC, a Joint Venture (Contractor);

WHEREAS, Project #1526, Golden Gate Bridge Suicide Deterrent System Construction involves fabrication and installation on the Golden Gate Bridge (Bridge) of a horizontal stainless steel net supported by cantilevered steel brackets along the west and east sides of four Golden Gate Bridge structures: the South Approach Viaduct, the Fort Point Arch, the Suspension Bridge, and the North Approach Viaduct, and construction of a tall vertical railing at the North Anchorage Housing;

WHEREAS, Project #1526 is funded in part with monies from the Federal Highway Administration (FHWA) received through the Metropolitan Transportation Commission and Caltrans, and follows the rules and procedures set forth in the California Department of Transportation (Caltrans) Local Assistance Procedures Manual (LAPM) for federally assisted projects;

WHEREAS, in conformance with the LAPM, the District has developed a Construction Contract Administration Plan for the project, which provides that administration and management of the project construction by the District is performed by the Engineering Department staff with the assistance of consultants with expertise in various aspects of construction administration and engineering;

WHEREAS, as has been previously reported, the Contractor has not progressed the work as required by the contract and the District now estimates that they will not complete the installation of most of the physical suicide deterrent system until early 2024 and will not complete the remaining work until mid-2027;

WHEREAS, as a result of the continued delay in construction completion, engineering staff and consultant support services costs will continue to increase, as detailed in the staff report;

WHEREAS, staff has reviewed the Project #1526 budget and determined that the budgets for the Engineering staff and for consultant construction scheduling, estimating and claim review support services will be depleted by the end of December 2023 and are required to be increased in order to continue with supporting the project implementation;

WHEREAS, staff anticipates that the same level of Engineering staff contract administration and construction engineering services, construction schedule, estimating and claim review services, provided for the past year will be required through the end of 2024;

WHEREAS, a budget increase is necessary for Engineering staff costs to ensure continued construction administration, engineering and inspection of contract work, and administration and monitoring of consultant support services contracts, and staff recommends a budget increase in the amount of \$4,200,000 to the Project #1526 staff budget to allow for a continuation of these efforts through approximately December 2024, with the understanding that Engineering staff will monitor the progress of the construction work and will make an assessment towards the end of 2024 of the remaining work and the additional budget amounts that may be necessary to finance additional support services required through the construction completion;

WHEREAS, by Resolution 2017-105, the Board authorized execution of Professional Services Agreement (PSA) No. 2018-B-07, Golden Gate Bridge Physical Suicide Deterrent System and Wind Retrofit Construction Scheduling and Claim Review Services, with Secretariat International, which has been amended on three previous occasions;

WHEREAS, a fourth amendment is necessary in order to assist the District in reviewing, evaluating and responding to the Contractor's schedule submittals, notices of delays, requests for additional compensation and claims and, at the request of Engineering staff, Secretariat International has provided a cost proposal in the not-to-exceed amount of \$1,108,305 for continuation of its services through approximately December 2024;

WHEREAS, Engineering staff has reviewed the cost proposal and found it to be fair and reasonable, and the District's Disadvantaged Business Enterprise (DBE) Program Administrator has verified that work under the proposed Fourth Amendment includes a proposed 1.57% DBE subconsultant participation;

WHEREAS, the Building and Operating Committee has so recommended, and the Finance-Auditing Committee has concurred, at their meetings of December 14, 2023; now, therefore, be it

**RESOLVED** that the Board of Directors (Board) of the Golden Gate Bridge, Highway and Transportation District (District) hereby authorizes a \$4,200,000 increase in Project #1526, *Golden Gate Bridge Physical Suicide Deterrent System Project* budget to finance the contract administration and construction engineering costs by the District's Engineering staff through approximately December 2024; and be it further

**RESOLVED** that the Board hereby authorizes execution of the Fourth Amendment to Professional Services Agreement (PSA) No. 2018-B-07, Golden Gate Bridge Physical Suicide Deterrent System and Wind Retrofit Construction Scheduling and Claim Review Services, with Secretariat International, Manhattan Beach, CA, in an amount not-to-exceed \$1,108,305, for continuation of expert construction scheduling and estimating and claim evaluation services through approximately December 2024; and be it further

AUTHORIZE EXECUTION OF ON-CALL PROFESSIONAL SERVICES
AGREEMENTS RELATIVE TO CONTRACT NO. 2023-D-092, CONSULTING
SERVICES FOR TOLLING, ELECTRONIC PAYMENTS AND DATA ANALYSIS

December 15, 2023

WHEREAS, since 2014, the Golden Gate Bridge Highway and Transportation District (District) has had an established bench of on-call consultants for technical support for toll operations, including both ongoing operational support and on-call assistance for a variety of technical services related to the toll operations program and electronic revenue;

WHEREAS, over the last four years, the District has spent approximately \$4.72 million on on-call support under its current professional services agreements for technical support for toll operations relative to Contract No. 2018-B-05 and staff anticipates the need for higher levels of support on an ongoing basis due to upcoming capital projects;

WHEREAS, the District determined it would be beneficial to establish a new bench of on-call consultants given the significant change over the last five years in the number and variety of vendors who perform this type of work and the additional work areas required to support and meet the specialized needs of toll collection-related programs and time sensitive projects;

WHEREAS, on October 13, 2023, the District issued Request for Proposals (RFP) No. 2023-D-092, Consulting Services for Tolling, Electronic Payments and Data Analysis, to seek proposals from qualified firms to provide on-call project management, technical, and professional support services and, by the submission due date of November 9, 2023, the District received eleven proposals;

WHEREAS, after considering the written proposals and references, the Selection Committee determined that selected firms met all the requirements the District requested for each category for which the respective firms proposed, and the qualifications of each selected firm was scored appropriately and determined to meet the District's need for the on-call services requested;

WHEREAS, staff, the District's Attorney, and the District's Disadvantaged Business Enterprise (DBE) Program Administrator reviewed the proposals and found the selected firms submitted all required documents, and their proposals are technically responsive to the specifications;

WHEREAS, the DBE Program Administrator has determined that the selected firms have complied with the DBE requirements and several proposers are DBE firms and have included DBE and SBE sub-consultants to perform work based on individual task orders; therefore, DBE and/or SBE participation is anticipated during the performance of these contracts; and

WHEREAS, the Golden Gate Bridge Highway and Transportation District's (District) Capital and Grant Programs Department (C&G) plans to contract for certain professional support services in areas where factors such as the degree of specialization required or timeliness of work would not enable the use of permanent, in-house staff;

WHEREAS, services requested from outside firms include economic/cost benefit analysis preparation, grant application development and writing, capital planning assistance, integration of asset management data, and technical support for large, discretionary grant applications;

WHEREAS, the Golden Gate Bridge, Highway and Transportation District (District) is preparing for the 2024 State and Federal Legislative sessions, working actively with its legislative advocates to follow a variety of issues that affect or potentially could affect the operations of the District;

WHEREAS, in 2023, the District will continue to monitor legislative bills that could have a funding impact on the District's overall operations and specific to the California State legislative session, District staff will continue to monitor and weigh-in on potential legislation affecting the District and our partner transit agencies while keeping in mind the District's resolution declaring a climate emergency and the District's resolution regarding racial equity and justice;

WHEREAS, approval of a legislative platform establishes Board-approved priorities to provide direction on legislative and policy activities on important issues;

**WHEREAS**, the Governmental Affairs and Public Information Committee at its meeting of December 15, 2023, has so recommended; now, therefore, be it
