Public commenters calling in will be called upon to speak in the order in which their call was received. Please remember to turn down the speaker or any other devices in the room before providing your public comment to minimize audio feedback.

Each individual will be allotted up to three (3) minutes for public comments concerning items of interest within the subject matter jurisdiction of the Public Hearing. Said time frames may be extended only upon approval of the Board.
