Persons who wish to submit public hearing testimony during the public hearing may do so in person or through the call-in number at (415) 569-6446 and are encouraged to call in at least 15 minutes prior to the start of the public hearing.

During the public comment period of the hearing, those attending in-person will be called upon to speak first before those on the telephone. Public commenters calling in will be called upon to speak in the order in which their call was received. Please remember to turn down the speaker or any other devices in the room before providing your public comment to minimize audio feedback.

Each individual will be allotted up to three (3) minutes for public comments concerning items of interest within the subject matter jurisdiction of the Public Hearing. Said time frames may be extended only upon approval of the Board.

Upon request, the Golden Gate Bridge, Highway and Transportation District will provide written agenda materials in appropriate alternative formats to individuals with disabilities.
