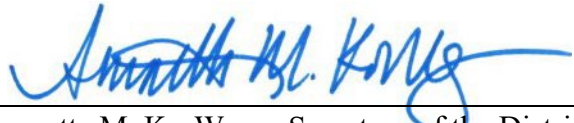

Please remember to turn down the speaker or any other devices in the room before providing your public comment to minimize audio feedback.
