QUESTIONS & ANSWERS

Q1: Is the DBE Program limited to transportation related contracts?

No. Several industries are able to be certified. Airport Concession DBEs Authority (NVTA) A: (ACDBEs) cover businesses like food and beverage and retail operations.

Q2: If I have DBE certification here in Northern California, is also good for Southern California?

Yes, the DBE Program is a federal program that is administered from A: state to state. So, if you are certified by a Northern California agency, your certification is recognized statewide.

Q3: On the same note, if I only have my DBE certification for California, can I use it in Arizona - Colorado? If not, what do I need to do in order to expand it?

Since the program is administered by each state, you will have to go A: through the interstate certification process in order to be recognized in the state you would like to operate in.

Q4: If I am already doing certification for Disabled Veteran and Woman Veteran Owned Small Business, is it really necessary to get a DBE certification as well?

A: If you are looking to bid on DBE contracts, then yes. Those other certifications do not cross over.

How long are DBE certifications good for and is there an annual Q5: renewal requirement?

Certifications need to be renewed annually. A:

- Q6: I am a white Irish man, I lost my arm 23 years ago and am wondering if I am eligible to qualify?
- A: You can certainly apply. If you are able to demonstrate how your circumstance renders you socially and economically disadvantaged, your firm may be able to be certified.
- Q7: What is included/not included in the Personal Net Worth calculation? For example are retirement accounts, pension accounts, and homes included?
- **A:** Yes, most assets as well as liabilities are assessed to determine your net worth.
- Q8: Do we only certify once or annually?
- A: You are certified once then there is an Annual Update Affidavit (AUA) that needs to be submitted along with other documentation yearly.
- Q9: If your firm was previously certified but the certification lapsed, do we need to recertify or just do an Annual Update Affidavit?
- **A:** If your firm was decertified, you will need to recertify by starting the process over again.
- Q10: Can you elaborate more on Personal Net Worth in regards to pension accounts? How do you value a pension that depends on how long you live?
- A: In respect to a pension for calculating the amount for Personal Net Worth purposes, an owner reports the full value of the pension, if distributed today, minus taxes, interest and penalties.
