



## STRATEGIES FOR SUCCESS

#### **Attend Pre-Proposal Meeting**

• Clear up any confusion regarding project details, scope of work, and solicitation of documents.

#### **Q&A Period**

 Opportunity to address any uncertainty with the proposal requirements.

#### **Proof Read Proposal**

• Improve the quality of proposal by ensuring there are no typos, grammar errors, etc.

#### Proposal Meets Requirements

• Very important proposal meets evaluation criteria to prevent being considered "non-responsive."

#### **Interview Preparation**

• Well-crafted presentation demonstrates professionalism and helps to better understand vendor proposal.

#### Request Debrief Meeting

 Vendors who are not selected for a proposal can request a debrief to understand ranking and opportunities for improvement.
