PROJECT LOCATION: On the Golden Gate Bridge and U.S. Highway 101 in the City and
County of San Francisco and 0.6 miles North of the Golden Gate
Bridge in Marin County, California.

DESCRIPTION OF NATURE, PURPOSE AND BENEFICIARIES OF PROJECT:

The nature of the project is to furnish and install a moveable median barrier system on the Golden Gate Bridge and portions of Highway 101 north of the bridge.

The purpose of the project is to enhance safety and minimize the potential for crossover collisions on the Golden Gate Bridge and its approaches by installing a physical barrier to replace the plastic tubular pylons, which are currently used to delineate opposing directions of traffic on the Golden Gate Bridge, and to transition traffic from the approach traffic lanes to the six Golden Gate Bridge traffic lanes.

The project includes furnishing and installing the moveable median barrier system and barrier transfer machines, removing a portion of the permanent median barrier on Highway 101 north of the bridge, performing minor excavation and reconstruction of the highway median and shoulders, modifying the existing drainage system along the highway shoulders, modifying existing and installing new changeable message signs, removing and reconstructing a portion of the easternmost Toll Plaza toll booths at the southern end of the bridge, electrical work, modifying the lane striping, and associated work items as required to complete the project.

The beneficiary of the project is the Golden Gate Bridge, Highway and Transportation District and the public.




