RESOLUTION NO. 2008-109

**APPROVE ACTIONS RELATIVE TO GOLDEN GATE
TRANSIT SERVICE CHANGES**

December 19, 2008

WHEREAS, the Transportation Committee/Committee of the Whole, at its meeting of December 12, 2008, have so recommended; now, therefore, be it

RESOLVED that the Board of Directors (Board) of the Golden Gate Bridge, Highway and Transportation District hereby approves implementation of the following Golden Gate Transit (GGT) service changes:

1. Redeploy underutilized commute bus service on the following GGT Bus Routes to address overcrowding on other routes:
 - a. Discontinue one trip on Route 8;
 - b. Eliminate all five service trips on Route 9;
 - c. Eliminate three midday service trips on Route 60; and,
 - d. Eliminate one round trip on Route 75.
2. Reconfigure regional basic bus service on the following routes to improve travel times and service productivity:
 - a. Modify Route 80 service during weekday daytime periods (approximately 6:00 a.m. to 7:00 p.m.) to eliminate stops between Novato and San Rafael and between San Rafael and the Spencer Avenue bus pad stop.
 - b. Create new Route 101, express bus service between Novato and San Rafael and between San Rafael and the Spencer Avenue bus pad stop, with replacement service to be provided by other GGT routes.
 - c. Modify Route 10 service to operate on Van Ness Avenue and Lombard Street instead of along Geary Boulevard within San Francisco, and extend this route to Manzanita Park-and-Ride Lot and Strawberry in Marin County.
 - d. Create new Route 92 to provide weekday peak period service from Marin City and Sausalito to points along the Geary Boulevard corridor.
